THE MONTGOMERY FAMILY

The first now known Montgomery ancester was Worthington (Worthy) Montgomery. I believe (strictly my own conjecture) he was the son of Hugh R. Montgomery and Alley Wilson who were married in Allegany County, Maryland 24 February, 1821. According to the Montgomery family Bible, Worthy was born 6 February 1822. In the 1850 census, the first census to list any family members other than the head of household, the oldest child listed in the family of Hugh and Alley was a daughter, Mary, born in 1824, leaving a gap of some three years between their marriage and the birth of this daughter which is rather rare for those times. So, it was possible that Worthy was their first born. In this census Hugh and Alley are listed as house number 2637 and Worthy is listed as house number 2602. This indicates they lived not too distant from each other.

In the 1860 census of Hampshire County, West Virginia there is an Allie Montgomery listed as head of household with two of her children, Louise and William, living with her and listed in house number 8 and family number 8. Worthy and his family are listed in house number 9 and family number 9. In the 1870 census of this County there is listed an Alla Montgomery, (house and family #210), a William Montgomery (house and family #137) and a Worthy Montgomery (house and family #47) all in Springfield Township. Also in the 1870 census, both William Montgomery (son of Hugh) and Worthington Montgomery are listed as boot and shoemakers which seems to be a strong indication that they were family connected and more than likely brothers.

(1)Worthington Montgomery, born presumably in Allegany County, Maryland is found in the 1850 census of that county, as head of his household, age 28, with his wife Meranda (or Marenda) and two children, Washington, age 5 and Mary, age 3. His occupation was carpenter. By 1860 he and his family are living in Hampshire County, West Virginia moving there sometime between December 1851 when their third child, Eugene, was born in Allegany County, Maryland and the birth of their fourth child, Henry, who was born in West Virginia, presumably in Hampshire County, in December of 1853. His occupation was listed as Cabinet maker in this census.

In the 1870 census of Hampshire County, West Virginia Worthy's occupation is listed as boot and shoe maker as was his son, Washington, and his younger brother, William. By 1880 Worthy is back in Allegany County, Maryland living a few houses away from his son, Lawson, and his occupation is listed in that census as deputy sheriff. He was truly a jack of all trades. It is not known where he lived or what other occupations he adopted during the remaining 17 years of his life.

(2)Washington Montgomery, first child of Worthington (Worthy) Montgomery and Marenda Browning was born in Maryland, probably in Allegany County and presumably remained in this county until the family moved to Virginia sometime between 1851 and 1852. (The state of West Virginia was not organized until 1861, under the name of Kanawha, and was admitted into the Union in1863 as the state of West Virginia.)

Washington appears in the 1850 census of Allegany County, Maryland with his parents and a younger sister and in the 1860 census of Hampshire County, Virginia again with his parents and now five siblings. In the 1870 census of Hampshire County, West Virginia, in the town of Romney, he is listed in the household of John S. Suders and his occupation in stated as "...working in boot & shoe...". In the 1880 census of Allegany County, Maryland, in the town of Westernport, he now is the head of household with his wife Elizabeth and three children and two sisters in law, Susan and Agnes Patterson. No occupation was listed for him in this census.

He is still to be found in the 1900 census of Allegany County, Maryland and still in Westernport with his wife Elizabeth and two children, a daughter, Ora, age 10 and a son, Robert, age 1 both born in Maryland and presumably in Westernport, Allegany County, Maryland.

(3) Eugene Montgomery (our ancestor) third child of Worthy Montgomery and Marenda Browning, was born in December of 1851. The family story alledgedly claims his birthplace to be in both Maryland and West Virginia for the bed in which he was born was supposedly on the state line dividing the two states. However, he is listed in all the census records in which he appears as being born in Maryland. The Montgomerys seemed to move back and forth between Allegany County, Maryland and the counties of Mineral and Hampshire in West Virginia. Eugene and several of the later Montgomery descendents moved deeper into West Virginia to the counties of Upshur, Harrison and Randolph.

Eugene's life was touched by much sadness. He married three times and outlived all three wives, losing the first wife to Tuberculosis (Consumption) and the last two to cancer. Two of the children of his second marriage died at young ages. The third child of that marriage was born with a physical deformity but lived to be quite elderly.

Eugene is first found in the 1860 census of Hampshire County, Virginia in the Springfield Township with his parents, Worthy and Marenda and five siblings and again in the next census, 1870, in the same county (except it is now in the state of West Virginia) and the same township and again with five siblings. However, his older brother, Washington, is no longer in this household but a younger brother, George is added to this family.

In the 1880 census Eugene appears in Mineral County, West Virginia, has been married for eight years and has a son, Charles H. In this census his wife, Rachel, is listed as being ill with Consumption.

Two years after Rachel's death in 1880, he married for a second time to Mollie Christina Arnold. There were three children born to this marriage, a son, Worthy Cornelius who died in 1893 at age eight and a daughter, Sallie, who died in 1887 at age one year and two months. The third child, a son, Eugene Wilbur, born in 1887, had no arms below the elbow and both feet clubbed. He ran away from home at an early age, after his father had married for the third time and the family had moved to Arkansas, and joined a circus.

Not quite two years after Mollie's death in 1895, Eugene married for the third time, to Clarabel Ada Parsons (our ancestor) and shortly after this he and Clarabel and his son, Wilbur, moved to Russellville, Pope County, Arkansas where his Mother-in-law owned a small farm.

This move added Farmer to his varied list of occupations. According to family stories he worked during the 1870's with his father in the boot and shoemaker trade. In the 1880 census his occupation was listed as a Railroad brakeman. In the 1900 census (of Pope County, Arkansas) he was a carpenter but by 1910 he was listed as a farmer and at sometime or other, he had been a school teacher.

In the 1920 census of Pope County, Arkansas, there was another child listed in this family, a daughter named Lillie aged seven but this author had no knowledge of this child, had never heard Viola, or her husband, Adell, ever mention another child and all inquiries of other members of this Montgomery family have resulted only in shock. NO ONE that I have contacted ever knew of this child.

(4)Henry Montgomery, fourth child of Worthington and Marenda (Browning) Montgomery was born in Springfield, Hampshire County, Virginia but very little else is known of this man. In 1880 he was still living at home, with his parents and his younger brother, George, in Allegany County, Maryland but, in 1882 he married Ida V. Edwards in Mineral County, West Virginia and took up residence in that county in the town of Keyser. He was still living there in 1920 for the census of that year places him at 119 Center Street in Keyser City with his wife, Ida, his son, Bruce, his daughter Faye and her husband, Hugh Edwards.

It seems he lived in this county from the time of his marriage until the end of his life in the fall of 1920 for records of this county tells us his children were all born there, that one son, Victor, died there at the age of two years and is buried there and he himself if buried in the Queen's Point cemetery in this county.

(5)Lawson Montgomery, fifth child and fourth son, of Worthy and Marenda (Browning) Montgomery was, like his brother, Henry, born in Hampshire County, Virginia in September of 1856.

There is some confusion as to the date and location of his marriage to Louisa Kight (Kite). The IGI (International Genealogical Index) places his marriage in Westernport, Allegany, Maryland on November 7 of 1877 but marriage records of Mineral County, West Virginia show his marriage there on November 21, 1877. On both records his wife is shown as Louisa Kight. The 1870 census records places him with his parents and siblings in Hampshire County, West Virginia. The 1880 census records shows him as head of his own household and living in Westernport, Allegany, Maryland with his wife, Louisa and their son, Vernon, who was born in Maryland, probably in Westernport. I have been unable to locate this family in the 1900 and 1910 census records but, in 1920 the census records show him living at 5 Dundee Street, Piedmont, Mineral County, West Virginia with his married daughter, Leafy Matthews (Mrs. John W.). His occupation at that time was listed as carpenter and his son-in-law as an electrician and both working in a paper mill.

(6)William Montgomery Sixth child of Worthy and Marenda was born in Hampshire County, Virginia in the fall of 1858. Very little is known of this man. The location and date of his birth is known and the date and place of his marriage to Susan Buckalew. In 1873, when he applied for his marriage license he listed his occupation as carpenter. Where he resided for the subsequent 17 years is yet unknown but in the census records of 1900 he is found in Allegany County, Maryland with occupation listed as farmer. There are six children listed in his household in this census. Susan, his wife, is listed as the mother of 8 children with 7 living.

In the 1910 census of Allegany County, Maryland there is a William Montgomery listed who may have been this William. However, there are several discrepancies in the information. For example: 1.) He is listed as being married 30 years which would have put his marriage date in 1890 (our ancestor was married in 1873) 2.) His mother's birthplace in given as Scotland. (our ancestor's mother was born in Maryland) His wife's name in given as Rebecca which could be Susan R. (Buckalew) Montgomery's second christian name. She is identified as the mother of eight children with six living. It is this writer's belief that their youngest child, George, born in 1898 and who appeared in the 1900 census had probably died prior to 1910 for he does not appear in their household in the 1910 census nor in the 1920 Census. Two children are listed in the household; William, age 20, and James, age 16. In this census the occupation of all three of the male members of this household was Miner, coal mines.

In the 1920 census of Allegany County, Maryland in the town of Westernport, William appears in the household of his son, James, as a widower. His occupation in this census is listed as carpenter, builder.

There is an old photograph, identified by Viola (Montgomery) Kelley as "Uncle Will" and prsumably it is of this man. It was taken in the early 1920's and shows him to be quite elderly.

(7)George E. Montgomery, the seventh child of Worthy and Marenda Montgomery, was born some 10 years after his brother, William.

It was on a billing form of a bicycle repair and service shop in Cumberland, Maryland, owned, or run, by this man in the 1890's that the names of all of Worthy and Marenda's family were copied giving all their birth dates and some of their death dates. This document is in the possession of Bertha Montgomery (Myron Kent Montgomery's widow) in Biscoe, Prairie County, Arkansas as of 1995.

George first appears in the 1870 census records for Hampshire County, West Virginia with his parents and siblings, with the exception of his oldest brother, Washington, who had married, and again in the 1880 census for Allegany County, Maryland with his parents and his older brother, Henry. By 1900 he is found in th census records for Allegany County, Maryland as head of his own household, living in Cumberland. At this time there are three children in this family. In 1910 he is still living in Cumberland, Allegany, Maryland and there have been born to him and his wife, Emma, three more children. The 1920 census finds him still in Cumberland, another son, George K. has been born and is living in this household along with two sisters, Marenda and Leona. In both the 1910 and 1920 censuses George E. Montgomery's occupation is listed as machinist.



Children of Washington (son of Worthy) Montgomery:

Herbert Montgomery was the first child of record born to Washington and Elizabeth (Patterson) Montgomery. He appears in the 1880 census of Allegany County, Maryland in the town of Westernport in the household of his parents. At the time of this writing no further record of Herbert Montgomery has been found until the 1910 census of Allegany County, Maryland where a Herbert Montgomery is listed with his wife, Gertrude, and their six children. This Herbert Montgomery again appears in the 1920 census of Harrison County, West Virginia with his wife, Gertrude May and four children.

In Herbert Montgomery's will he designates three of his devisees as Mrs. Mary McMillen, Mrs. Charles McKell and Mrs. Lilliburn Talkington. Mary W. Montgomery is identified as Miss "Willie" Montgomery in the marriage records of Mineral County which give birthplace and parents names which makes identification pretty certain.

Robert Montgomery (son of Washington, son of Worthy) was the fourth child of Washington and Elizabeth (Patterson) Montgomery and the last of record. He first appears in the 1900 census of Allegany County, Maryland in the household of his parents.

By the 1910 census of the same county, he is married and living in the household of his father-in-law, Charles A. Kight.

In the 1920 census, still of Allegany County, Maryland, he appears still in the household of his fanther-in-law. His widowed mother was also listed in this household as a boarder. Robert's occupation is listed in this census as Carpenter in a paper mill.

In the 1900 census records of Randolph County, West Virginia he appears as head of household with wife, Nettie and one son Fay H. His occupation is listed as Laborer - plainer. This was probably in a saw mill for he was still working at a saw mill in the early 1920's when Eugene traveled east with his third family for a visit.

In the 1910 census records of the same county his family has increased by two more children and his occupation is still Laborer - lumber mill.

Charles' children were about the same ages as the children of his father, Eugene, by Eugene's third marriage so that Eugene had children and grandchildren all around the same ages.

Eugene Wilbur Montgomery (son of Eugene, son of Worthy) was the third child born to Eugene Montgomery and Mollie Christina Arnold. An older brother, Worthy Cornelius, died when he was about eight years old and an older sister, Sallie, died when she was about two years old.

Eugene Wilbur Montgomery was born without arms from just below the elbows and he was club-footed - both feet. After the death of his mother, Wilbur stayed with Florence and Albert Kreemer. He related to Bertha (Lee) Montgomery that he remembered playing with the two Kreemer children in an old hollow log near their house where an old sow and her piglets had made a nest. When his father, Eugene Montgomery, married Claribel Ada Parsons (sister to Florence Kreemer) and they decided to move to Arkansas, they brought Wilbur with them. Unfortunately, from Wilber's viewpoint, it was a very unhappy household for him and he ran away before he was 15 and joined a circus. A circus performer became his life-long career. He said he had a comedy act but he evidently was reluctant to talk about his work so little is known among the family members about his career. He made several trips to California and Arkansas to visit his half brothers and sisters and their families in his later years and was very warmly welcomed.

She traveled east when a young woman, presumably to either visit or to live with relatives, probably her aunts Florence Kreemer and/or Ellen Cheuvront. She attended the Washington and Irving High School in Clarksburg, West Virginia for a time and it is said she also attended a college somewhere in the east, probably in West Virginia, before returning to Arkansas.

After her marriage, at age 22, to Cye Harden, she and her family lived in and around Russellville, in Pope County Arkansas until the early 1930's when they moved to Pushmataha County, Oklahoma where work could be had in the mines and on the near by farms. Their fourth child was born there and two years later died there.

May and Cye had rented a large house near the little community of Jumbo and May's brother, Myron and his bride rented a room with them, taking meals with May and Cye's family.

The two families, May's and her brother Myron's, moved to Sand Springs, Tulsa County, Oklahoma, in the late 1930's to join their sister's family. An uncle, Myron A. Parsons, financed the purchases of homes for these three families in the community of Pratt Addition just outside the small town of Sand Springs. These families remained there until the 1940's. Early in 1940, possibly the later part of 1939, May and Cye left for California and traveled as far as Phoenix, Arizona where May became ill and died. Cye returned to Oklahoma for awhile but later moved back to Arkansas, remarried and remained in Arkansas until his death in 1972.

Myron Kent Montgomery (son of Eugene, son of Worthy), the second child and only son of Eugene Montgomery and Claribel Ada Parsons, was afflicted with asthma until after he was 30 years old. He often told of his mother using the plant he called Jimson Weed to ease his breathing. After his mother's death he continued to live with his father and his two younger sisters, Florence Ellen and Viola, in the house that Eugene had built when he came to Arkansas in 1897 or 1898. After the death of his father, Myron still lived in the family house. His sister, Viola, married at the end of 1925 and his sister, Florence Ellen, married in 1930 and she and her husband, Clio Thompson were now living in the family home and were still there it is believed when Myron left to go to Jumbo, Pushmataha, Oklahoma with, or to join, his older sister, Cora May and her family.

He married Bertha Lee in Jumbo, Oklahoma. These families later moved to Sand Springs, Tulsa, Oklahoma where, with financial help from an uncle, Myron A. Parsons, they all purchased homes in Pratt Addition, a small community near the small town of Sand Springs. Myron and Bertha remained there until they moved sometime in the 1940's to Hanford, California.

Myron and his family did not stay long in California but soon moved to Arkansas where he remained until his death in Prairie County, Arkansas in 1988. His widow and family were still residing in Prairie County, Arkansas in 1995.

Florence Ellen Montgomery (daughter of Eugene, son of Worthy) was the third child of Eugene Montgomery and Claribel Ada Parsons. This writer's knowledge of Florence Ellen's life is sketchy. It is assumed that she remained in her father's household until his death in 1928. She married in 1930 and she and her husband. Clio

Thompson, presumably remained in the family home and probably continued to live there until 1934 when the property was sold by the Montgomery heirs. Viola Eugenia Montgomery (daughter of Eugene, son of Worthy), the youngest of Eugene Montgomery and Claribel Ada Parsons' children, was born in the spring of 1908 and was named simply Viola Montgomery. When she was about 12 years old she herself chose her second name of Eugenia.

When she was ten years old she lost her mother to cancer and took over the responsibility of the household. Since her sister, Florence Ellen, did not marry until 1930 it is assumed that her work was either outside the home or in the fields or perhaps the household chores were shared. Viola's education was continued only through the 8th grade and after that she supposedly taught school somewhere in Pope County for one year.

She was an attractive young woman and a good natured person for she often told of the teasing and the jokes played on her because her birthday was April 1st - April Fools Day. She liked to sing and thoroughly enjoyed the "...all day singin' and dinner on the ground..." outings of the church.

She and Clarence Adellbert Kelley were married on Christmas Eve in 1925 and evidently lived in the Montgomery home until the birth of their first child in December of 1926. Soon after that they moved to a rather isolated community always spoken of as

"...out under the Cagle Rock...". They may have remained at this place until they moved to Beggs, Okmulgee County, Oklahoma where Adell and his brother, James William, found work on the farm of a Mr. Wilson.

While living in Beggs, Viola's father, Eugene Montgomery, came by train to visit. This was probably sometime during early summer of 1928 judging from old photographs showing a field of cotton to be about waist high but not yet bolled.

It must have been shortly after this time that Viola and Adell moved to Sand Springs, Tulsa County, Oklahoma for their second child was born there in 1931. Adell had relatives living in Sand Springs and about 1932 he and his growing family moved into a house owned by one of his uncles, Gorge Gentry. Adell found work in the Cotton Mill in Sand Springs.

This family later moved into the town of Sand Springs and lived in one rented house after another until, with financial help from Viola's uncle, Myron A. Parsons, they purchased a modest home in the community of Pratt Addition just across the Arkansas river from Sand Springs in about 1936 or 1937. They remained there until 1942 when they moved to California where Adell's sister, Lucy Waits, lived in El Cajon, a small town east of San Diego.

By this time the United States had entered World War II and Adell found work with the Santa Fe Railroad and later the U. S. Navy as a civilian employee and Viola went to work in the defense plants.

Soon after the end of the war, they moved to Missouri and lived there for a brief time but then returned to California, to the San Juaquin valley and later back to the San Diego area where they remained until their deaths; Viola's in 1952 and Adell's almost 30 years later in 1981.

Ethel B. Montgomery (daughter of Henry, son of Worthy) was the first child, of record, born to Henry Montgomery and Ida V. Edwards. She was born in Mineral County, West Virginia and it is believed that she lived most, and perhaps all, of her life in that county. Although very little information has been discovered about this person, there was found a record of her marriage in Mineral County to a Charles E. A. Burnap when she was 16 years old. The record gives her birth date and place, her place of residence and her parents' names. That record also states "Written consent of Ida Montgomery produced and filed." It also gives the date of the license and the date of the marriage and the name of the person who performed the ceremony.

However, in the 1910 census of Mineral County she is listed in the household of her father, Henry Montgomery, under her maiden name, Montgomery, and as a single woman with no occupation.

She does not appear, under the name of Montgomery, in the 1920 census of Mineral County, West Virginia.

Marenda is still listed in her parents household in the 1920 census of the same county, same city and still on Frederick Street, as a young woman of 23 with a career as a stenographer for a lawyer. It is not known at this writing whether she later married or not.





Evilyn, Gladys M., Herbert, Jr., Floyd E., Lola M. and Faye M. Montgomery (children of Herbert, son of Washington, son of Worthy) were all born in West Virginia except the first two, Evilyn and Gladys, who were born in Maryland.

The last information found on this family is in the will of Herbert Montgomery (son of Washington), filed in Harrison County, West Virginia in Vol. 18, page 312 and dated 6 October 1932. It mentions his wife, Gertrude May, his son Floyd E., a Mrs. Mary McMillan, a Mrs. Charles G. MacKell and a Mrs. Lilliburn Talkington. Presumably the last above three names are the married names of three of his daughters. There were two other daughters in this family and they are not mentioned in the will nor is his son, Herbert, mentioned. Nothing more is known by this writer concerning this family.

Walter H. and James M. Ross (sons of Mary W. ("Willie") Montgomery, daughter of Washington, son of Worthy) were, presumably, the only children born to Mary W. ("Willie") Montgomery and Martin Ross:

Robert K. Montgomery (son of Robert, son of Washington, son of Worthy) was presumably the only child of Robert Montgomery and Cora B. Kight

1920s. This writer has no more information at this writing concerning these grandchildren of Eugene Montgomery.

At sometime during his CCC or military career, he served in Alaska for there are photographs in Viola (Montgomery) Kelley's collection which he sent to her with notations on the back of them.

He owned a very successful vacumn cleaner sales and repair shop in the Riverside area and later in San Bernadino, California. After his retirement, he and Alene moved to Marshal, Texas where Alene had relatives.

. There were two unsuccessful marriages prior to his marriage to Mrs. Alene (Kelley) Phillips and there were children of those marriages.

With this third marriage Jay Foster acquired a step-son, James Alton Phillips, who later used the name Harden. Jay and Alene had twin daughters, Sandra and Linda.

Three of the above children of Florence Montgomery, and possibly the fourth, inherited the family kidney disease known as Bright's Disease. Florence Ellen (Montgomery) Thompson and her sister, Viola Eugenia (Montgomery) Kelley both died of this disease as did Florence Ellen's daughters, Elizabeth Louise and Thelma Dean, William Thompson had a kidney transplant in 1984 and has survived (as of 1995) in relatively good health. It is not known by this writer if Virgil Eugene Thompson is afflicted with the disease.

<u>Viola Irene Kelley</u> (daughter of Viola Eugenia Montgomery, daughter of Eugene, son of Worthy) is the oldest child of Viola Montgomery and Clarence Adellbert Kelley and, except for legal purposes, has seldom used the name of Viola.

She was born in the little town of Russellville, Arkansas but, before her first birthday, her family moved to Beggs, Okmulgee County, Oklahoma and before she started school the family moved to the small town of Sand Springs in Tulsa County, Oklahoma where her father's relatives were living.

She began school at the Central School in Sand Springs and attended various other elementery schools in the town of Sand Springs as the family moved from one rented home to another until the late 1930's when the family purchased a home in a development called Pratt's Addition just outside the town. He continued to attend the Limestone school until the family moved to San Diego County, California. Where he attended the El Cajon Elementery school in the town of El Cajon, east of San Diego, for a short time until the family moved into city of San Diego. He graduated from Point Loma High School in 1949.

While still in Junior High School, he obtained work selling newspapers on the military bases in San Diego, using public transportation and his bicycle to go to and from work and school.
